

MT CARMEL 2021 SCHOOL CONTRIBUTIONS

<i>Every child is encouraged to take part in swimming lessons – If you agree to your child taking part in swimming lessons this is the charge to be paid and paid BEFORE swimming lessons take place in Term 4.</i>
